CREDILA INDIAN STUDENT LOAN PROGRAM THROUGH GEMS

The Credila Loan for Students is a program for Indian students studying abroad. They are required to have an Indian citizen as co-signer, and they repay the loan in rupees to the Indian bank. Credila is a subsidiary of HDFC bank, one of the Big Four banks of India.

[Lendwise](#) is a specialist loan provider based in the UK that is dedicated to education finance for individuals who are looking to fund their studies at world-class Higher Education institutions.

Lendwise aims to enable access to education through its affordable and flexible student loans.

Loans have a fixed interest rate and no early repayment penalties. Interest rates are personalized and depend on an applicant's overall profile including future earning potential. The application process is entirely online. Full-time programme students have access to a grace period that allows for repayment to start after graduation.

Variable rates:

Interest rates vary depending on the chosen loan and your personal financial situation.

There are no origination fees and no prepayment penalty.

Repayment term is from 5 to 15 years and varies according to the loan amount and the number of years spent at school.

US FEDERAL LOANS

HEC Paris is registered with the US Department of Education. HEC Paris students (US citizens or permanent residents) can be eligible to apply for Federal Direct Loans (Unsubsidized and Grad Plus loans).

Program and student eligibility are to be verified by contacting usfunding@hec.fr. These loans can help you cover the tuition fees and living expenses. HEC Paris' school registration number is G22934.

The information in this section is relevant to prospective and current graduate students and participants.

Please find below the loans rates for the 2020-2021 academic year:

- Direct Unsubsidized loans: 4.30% (+origination fees)
- Direct Graduate PLUS loan rate: 5.30% (+ origination fees)

You must meet the criteria set by the US Department of Education to be eligible for US loans but the HEC Paris Financial Aid Office will confirm your eligibility. The basic eligibility criteria are listed on the Federal Student Aid website.
