French-American Chamber of Commerce - New York and HEC Paris Announce Strategic Partnership to Promote Student Mobility between France and the U.S.

New York, NY – The French-American Chamber of Commerce in New York (FACC-NY) and HEC Paris are pleased to announce a strategic agreement to boost student mobility between France and the United States. Together, the two renowned organizations will actively promote the FACC Foundation's Serge Bellanger Business Scholarship Program, which benefits French and American students wishing to study on the other side of the Atlantic. The FACC-NY and HEC Paris will also increase cooperation on international career development programs, U.S.-based internships and joint events for the French-American business community in New York.
